

Temporarily Legal Residents Identification Checklist



General Information

- All documents must be **unaltered certified originals, certified amended originals, or true copies certified by the issuing agency**. Photocopies, notarized documents and online printouts are not accepted.
- If you are transferring driving privilege, you must also provide your driver license (valid or expired less than one year) or a motor vehicle report from your previous state/U.S. territory (dated within 30 days and showing a license that is valid or expired less than one year).
- Temporarily legal residents will receive a document bearing the phrase: "Not valid for federal identification, voting, or public benefit purposes."

STEP 1 – Identity and Lawful Presence

Bring **one** of the following:

- Unexpired Employment Authorization Document (I-766)
- Refugee/Asylee I-94 (with photo)
- Foreign passport with unexpired temporary I-551 stamp
- Unexpired foreign passport with U.S. visa and I-94

AND, if your I-94 class of admission is:

- F:** Your original, unexpired I-20A/B
- J:** Your original, unexpired DS2019
- K:** Your certified U.S. marriage certificate and I-797 Application for Adjustment of Status
- M:** Your original, unexpired I-20A/B
- V:** Your certified U.S. marriage certificate and I-797 Application for Adjustment of Status

Documents must verify through the USCIS SAVE verification system.

Individuals with an immigration status of B-1, B-2, WB, WT, CP, or NC are not eligible for a Colorado document.

*Individuals with an expired USCIS document **may** be eligible for issuance if an appropriate I-797 Notice of Action is presented and verifies through SAVE.*

STEP 2 – Residential Address

Bring **one** of the following:

Document must show your name and current Colorado residential (not P.O. Box) address - including street address, city, and state.

*Document must be dated within **1 year**.*

Electronic documents are accepted for proof of residential address.
