### Definition

A Low-Power Scooter (42-1-102(48.5)) means:

- A self-propelled vehicle designed primarily for use on roadways with not more than three wheels in contact with the ground.
- Has no manual clutch.
- Has either of the following:
  - A cylinder capacity not exceeding fifty cubic centimeters (50cc's) if powered by internal combustion; or
  - A wattage not exceeding four thousand four hundred seventy-six (4,476) if powered by electricity.

### Registration

- Low-Power Scooters are registered by a department approved registration agent or the Vehicle Services Unit.
- Low-Power Scooters must have an identification number stamped on the frame. The ID number will be recorded on the registration.
- Registration decal will be affixed to the frame in a conspicuous place.
- Registration shall be valid for a period of three years.
- Registration fee is \$5.49 for the three year period.

## Rules and regulations

The Vehicle Services Unit Agrees:

- To appoint the applicant as a registration agent to sell Low-Power Scooter registrations.
- To permit the agent to retain one dollar (\$1.00) for each registration issued.
- To furnish all necessary decals, forms and instructions.

The Registration Agent Agrees:

- To keep all money for Low-Power Scooter registrations in a separate fund. In the event of death or insolvency of the registration agent, the State of Colorado shall have a preferred claim on the fund.
  - That the Vehicle Services Unit may terminate this agreement if the registration agent goes out of business or if the rules and regulations are violated. Upon termination, all money and inventory will be surrendered to the Vehicle Services Unit.
  - To keep a complete record of all registrations sold.
  - To be responsible for all records, decals, and forms; these are to be kept at the place of business at all times.
  - To allow Vehicle Services Unit employees to examine decals and to audit records of Low-Power Scooter registrations.
  - To make monthly reports and remittances to the Vehicle Services Unit, paying the necessary postage.
  - To return all unsold, expired, voided and/or damaged decals by January 15th of every year.
