PROOF OF IDENTITY	<p>First time applicants must provide either: Foreign Passport, Foreign Consular Card, or Military ID (these are rare). Documents can be accepted for up to 10 years after their date of expiration. These are the only acceptable forms of identification for Standard credential applicants.</p> <p>Renewals need only their Colorado issued credential (license, permit, or ID) for identity.</p>
ITIN OR SSN	<p>Standard credential applicants, including youth under 18, must possess their own Individual Taxpayer Identification Number (ITIN) or Social Security Number (SSN); it must be in their name, they cannot use one from their parents.</p> <p>The three (3) accepted proofs of ITIN (Individual Tax Identification Number) are: an original letter from the IRS, a green, a wallet-sized card from the IRS, or a certified state tax return (Colorado form DR 0104). A certified state tax return (DR 0104) can be requested by the customer using form DR 5714, and will be sent by the Colorado Department of Revenue with a certification stamp and official signature.</p> <p>Applicants who have a social security number may provide the number verbally or can present a social security card, W-2, 1099, or pay stub if it contains the entire number. This is true for all Standard credential applicants.</p> <p>Renewals do not need to provide ITIN or social security proof again, as it is on file.</p>
PROOF OF COLORADO RESIDENCY AND CURRENT RESIDENTIAL ADDRESS	<p>Proof of Colorado residency and current residential address may be in the applicant's name or, for applicants under age 18, their parent's name.</p> <p>The applicant must provide certified proof of previous year tax filing (DR 0104) OR three (3) documents proving Colorado residency for 24 months. Acceptable documents for proof of Colorado residency include bills, bank statements, pay stubs, and postmarked first class mail. All documents must be dated, unaltered, contain a full residential address, and be in English or translated into English. For a full list of documents accepted for proof of Colorado residency refer to the CO-RCSA webpage.</p> <p>Applicants providing certified taxes must also provide one (1) proof of current residential address. For applicants providing documents showing 24 months of continuous residency, usually the current proof of Colorado residency document can also serve as proof of current residential address. If the current Colorado residency document does not have the applicant's current address, proof of current residential address may be provided separately and may be taken electronically.</p>
DR 2212	<p>A DR 2212 form is required for all Standard credential applicants. Minors presenting proof of Colorado residency in their own name use DR 2212A or DR 2212AS (Spanish); minors presenting proof of Colorado residency in the name of a parent use DR 2212B or DR 2212BS (Spanish). The applicant (and parent, for the DR 2212B) will complete this form. Technicians can access and print the appropriate DR 2212 through DRIVES.</p>
IF GETTING A PERMIT	<p>Someone 21 or over with a valid Colorado license (it may be a Standard credential license) must sign a DR 2460 Affidavit of Liability and Guardianship. The DR 2460 can be signed by a parent, guardian, grandparent with power of attorney, or any other responsible adult willing to assume liability. The signature must be witnessed by a driver license technician or notary.</p>
ADDITIONAL INFO	<p>Usual graduated licensing rules apply: the applicant must hold their permit for 1 full year or until they turn 18 and turn in drive logs totalling 50 hours (including 10 night hours) of drive time over 1 year.</p> <p>All applicants must have an appointment. Appointments can be made online or by calling 303-205-2335.</p>
