The Low-Power Scooter listed above meets the following criteria:</p> <ul style="list-style-type: none"> • A self-propelled vehicle designed primarily for use on roadways with not more than three wheels in contact with the ground. • Has no manual clutch. • Has either of the following (check one): <ul style="list-style-type: none"> <input type="checkbox"/> A cylinder capacity not exceeding fifty cubic centimeters (50 cc's) if powered by internal combustion; <li style="text-align: center;">or <input type="checkbox"/> A wattage not exceeding four thousand four hundred seventy-six (4,476) if powered by electricity. • I swear or affirm in accordance with section 24-12-102, C.R.S., under penalty of perjury that I now have in effect a complying policy of motor vehicle insurance including an operator's policy pursuant to part 6 of article 4 of title 10, C.R.S., or a certificate of self-insurance to cover the vehicle or operator of the vehicle for which this registration is issued, and I understand that such insurance must be renewed so that coverage is continuous. Noncompliance is a misdemeanor traffic offense, that the minimum penalty for such offense is a five-hundred-dollar fine, and that the maximum penalty for such offense is one year's imprisonment and a one-thousand-dollar fine. Owner's shall be required as a condition of obtaining a registration card to sign an affirmation clause that appears on the registration.
